

13th Annual Fern Ridge Light Parade

Registration Fees

**All entry fees \$10 due by December 6, 2016.
\$20 Fee per entry if paid after December 6, 2016.**

Loading of “group entries” will begin at 6:00 p.m. in the Veneta Elementary School parking lot (See attached Map). Staging will be at the West end of Jack Kelley Drive. Entries will be inspected and approved at that time. The parade will start at 7:00 p.m. sharp.

**IMPORTANT: ALL ENTRIES MUST BE REGISTERED BEFORE JOINING THE PARADE.
A COMPLETED REGISTRATION FORM AND A SIGNED WAIVER IS REQUIRED
FOR PARTICIPATION IN THE PARADE.**

For the safety and convenience of our participants and spectators, please follow the following guidelines

1. All entered floats must be **READY TO GO**, including riders, prior to arriving at the staging area on Jack Kelley Drive. If you are part of a large group (*i.e. the local school choir*) riding on a float, please meet and load your float in the Veneta Elementary School parking lot **BEFORE** moving to the staging area on Jack Kelley Drive.
2. **ONLY COMPLETED floats/entries will be permitted on Jack Kelley Drive.** Jack Kelley Drive will not be open to the public during the staging of the parade.
3. For safety reasons, stay with your float at all times during the staging lineup on Jack Kelley Drive. (*PLEASE, no running back to the car for forgotten items.*)
4. PLEASE decorate your entire float with lights, not just the trailer. If your float is drawn by another vehicle, please put some decorative lights on it as well. ***All entries must keep pace with the parade at all times. No stopping or delaying of the parade will be permitted. Please keep the spacing between floats to no more than 25' (1½ car lengths) between floats.***

Note: For safety reasons, PLEASE be sure that any animals in the parade are well lit, too. It's good for the parade watchers and it's safer for the animals.

5. FLOAT DIMENSIONS:
 - a) Height: Entries cannot not exceed 14'0"
 - b) Width: Entries cannot be wider than 15' 0"
6. Entries more than 25 feet in length must have 2 walking escorts.
7. Entry Escorts: It is the participant's responsibility to provide their own "walkers". Each escort **MUST WEAR A REFLECTIVE SAFETY VEST**.
8. Parade safety for the entrants and the spectators is an absolute priority. Candy may be passed out by walking escorts, but may NOT be thrown from the float.
9. Alcohol is not permitted on the floats during the parade. If alcohol is detected, you will be asked to remove yourself and your float from the parade.
10. No open fires are permitted on the floats.
11. Each entry must have at least a 5-pound fire extinguisher with their float; parade officials will be checking all safety requirements before the parade begins.
12. During the parade, should your float break down on the route, SAFELY move it to the side of the road.
13. Please use as many lights as you can on your float or parade entry. This is a light parade! The more lights, the merrier the parade!
14. If you enter an animal(s) in the parade, PLEASE plan on doing any scooping that is required. It helps insure that everyone has a good time and doesn't have to "clean-up" after others. Please provide your own scoopers!
15. All groups and clubs are encouraged to participate. Football team? Equestrian groups? Llama clubs? Scout and 4-H groups? Church Groups? Social organizations? Antique car clubs? You name it! If you live in our area, we hope you will put some lights on something and join us in this great community event.
