

Harvest Festival Recap

As summer wanes into fall and we begin to turn to the final months of the year, the Veneta Harvest Festival was the perfect marker for the new “leaf” fall represents. The September 11, 2021 event featured vendors, a car and motorcycle show, a chili cook-off, as well as a tribute to 9/11 and moment of silence. The Harvest Festival, hosted by Mid Lane Cares, was the largest event the City of Veneta has ever seen – a sure sign that members of our community are dedicated to coming together even in the most uncertain of times.

The event comes after a year’s absence for the Harvest Festival – in 2020, Mid Lane Cares was forced to postpone the event due to the COVID-19 pandemic. This year’s event came in a safer context and followed CDC guidelines. With these changes, Mid Lane Cares was able to organize a large outdoor event. Harvest Festival serves as a fundraiser for the Fern Ridge Service Center, which provides local assistance and programming for those in need. Vendors for the festival included artisans, artists, and makers of sweet and savory treats.

The Kiwanis Club of Fern Ridge hosted the Kiwanis Kruise-In, a classic car and motorcycle show that served as a fundraiser for the Kiwanis’ local services as well as the Doernbecher Children’s Hospital. Classic cars and motorcycles of all types lined the streets and filled parking lots, delighting the hundreds of attendees with a glimpse into the artistry of classic cars and motorcycles. The Kruise-In also featured a com-

Fall = Tree Planting Season

Contrary to common wisdom, fall may be the ideal time for you to consider some planting: trees! According to the Arbor Day Foundation, climates that experience all four seasons like ours have a best time for tree planting – the fall. Per the Foundation, “Planting in the fall gives trees an extra growing season before the stress of summer.

The combination of cooler temperatures and fall rain allows trees to establish their roots, making it easier on them to adjust to extreme heat or drought in the summer.” But what about fears of young trees in a harsh winter? According to the Arbor Day Foundation, trees enter a dormant state akin to hibernation and do not require extra care. After planting, make sure you follow normal care practices and your trees will be growing in no time!

Leaf Pick Up & Ditch Maintenance

Leaf Pick-Up

The City of Veneta will begin picking up bagged leaves left at curbside the first Tuesday in October through the end of January. There may be an occasion where the Public Works department is unable to pick them up as scheduled, if you feel that you were missed entirely, please call City Hall at 541-935-2191.

- ✂ Leaves will be picked up on Tuesday and Thursday of each week through the last Thursday in January.
- ✂ Bags are to contain leaves only, no garbage or other yard debris.
- ✂ Bags must be tied shut.
- ✂ As an alternative you may place leaves in your Yard Debris Roll Cart provided by Sanipac or use them for mulch or compost for gardens and flower beds.
- ✂ Citizens are asked to help reduce flooding by not raking leaves into gutters or storm drains.
- ✂ Depositing leaves or other debris in a drainage way or street is a violation of Veneta Municipal Code Chapter 13.15.010.
- ✂ If you want leaves for compost, please contact City Hall at 541-935-2191

Ditch Maintenance

City officials want to remind residents to clean up drainage ditches in preparation for another rain-soaked winter. "The flow (of water) should not be impeded in any way," says Public Works Director Kyle Schauer, adding that it is common for uninformed city residents to put leaves or grass clippings in the low spots of drainage ditches.

- ✂ Maintenance should ensure that water flows through ditches, so residents should never plug ditches and drainages or allow brush to inhibit flows.
- ✂ When drainage ditches get blocked it causes them to overflow, leading to flooding and major damage to roads, landscaping and nearby houses.
- ✂ Depositing leaves or other debris in a drainage way or street is a violation of Veneta Municipal Code Chapter 13.15.010.
- ✂ Residents should be aware that some properties contain protected wetlands. Special care should be taken when removing vegetation. If you have any questions about the wetlands you can call Associate Planner Lisa Garbett for more information at 541-935-2191.
